1. The BiSS-C Interface is protected by the German process patent DE 10310622 B4 (BiSS-C Patent) of the Licensor. Licensor grants to Licensee a non-exclusive, non-transferable, temporal unlimited simple License to use ICs produced by Licensor for the application of the BiSS-C interface. The User is not allowed to grant sublicenses. This permission is free of charge.
2. The annihilation or revocation of the BiSS-C Patent does not constitute claims of the User.
3. The Licensor has got the right to terminate this Agreement for an important cause by written notice without complying to a cancellation period in the case of the Licensee, a dominant shareholder of the Licensee or an affiliate controlled by the Licensee file a revocation action regarding the BiSS-C Patent or assert a claim against Licensor or third persons in relation to the use of BiSS-B or BiSS-C interface. In the case of termination of the Agreement for an important cause the termination gets effective from point in time the termination notice is received by the other party. With termination of the agreement the permission of the Licensee to use the invention protected by the BiSS-C Patent expires.
4. Licensor shall be liable for legal defects and the resulting consequential damages only if and when it fraudulently conceals a defect at the time of the conclusion of this Agreement. In this case the Licensee has got a claim for damages comprising that Licensee is put in the economic status as if Licensee never entered into this Agreement. Any further liability for legal defects is excluded.
5. Governing law of this contract is solely and exclusively German law. Regarding all disputes arising in connection with this agreement or its validity the courts at Düsseldorf/Germany have got exclusive jurisdiction, if the Licensee is a merchant, a juridical person governed by public law or a public special property with domicile respectively registered office in Germany. Furthermore the courts at Düsseldorf/Germany have got exclusive jurisdiction, if the Licensee has got his domicile respectively registered office outside Germany.
